# How do you see unequal access [digital equity] to technology and the internet creating a divide in Lincoln County? If you have an example either from your family or someone you know, please share it.

- Yes. As a former resident of Ivanhoe, I know how hampered our Ivanhoe friends are from access to different television programs offered through their smart tv's or addition of a fire stick or a roku device on their televisions. I try to explain how we can watch live Minneapolis television news reports because of our broadband. They tell me they aren't able to access because they can't get the service we have. So they are stuck using only Dish or Direct TV services. We have choices such as HULU and other Live streaming companies that are better priced and offer live tv. Then, with our roku device, we log into the KSTP or WCCO Minneapolis apps during news time. We are greatly advantaged over our Ivanhoe friends.

For the 'old' it was frustrating, knowing that pictures, songs, and services were out there somewhere, but with little skill or technology to access them. 'Young' and 'old' do not have a cut off year. My wife and I are in our sixties and have only a few challenges with online technology. I have peers and those only a few years older, however, who throw their hands in the air and do not bother with it when they get confused or realize their technology is outdated. Updating technology costs too much for many who are retired or are fixed, restricted incomes. So, I suppose the age divide is compounded by an economic divide. Some elderly have the income for updated technology, but do not have the habit or skill for updating technology. Either way, money or not, there is a divide.

In order to enhance the use of wind energy (and production of electricity) in our area, I would welcome more energy storage efforts. Years ago, Xcel had a semi trailer parked by a substation as it was studying how to store unused electricity. Thus far, the only proven technology for efficient storage of electricity is hydro storage. Europe has used it for decades. Excess electricity is used to pump water up a hill to a storage area. When there is need for extra electricity, valves open and the water flows downhill to power a hydro-turbine. Old, proven technology. While the lakes in Lincoln County are not large, most have hills by them which could hold water for such a purpose.
