Please describe how your home or business Internet [Broadband] connection supports or hinders your online world.

- 1. The Internet is used daily to support our online registration and communication.
- 2. My home internet is generally very reliable and allows me to work from home. Charter internet at my office has been more of an issue, especially considering what we pay for it.
- 3. As city government internet connection is of vital importance to maintaining a cities functionality.
- 4. I have always had access to reliable internet, enabling me to work remotely for several years. I'm no longer working remotely, but during the pandemic have had the option to work from home, which I've taken advantage of.
- 5. I am currently working from home and have internet services through Charter Spectrum. I have no issues with my internet service on my computer while in my home but does not work well once I am outside on my patio. Other than that I have no concerns with my service.
- 6. Essential to what we do every day, must have.
- 7. Quality access at home has allowed me to easily work remotely
- 8. School Internet lets students and teachers connect when offsite.
- 9. We are dependent on the internet to conduct our business

- 11. Although Arvig offers high speed internet, I find the service to be slow. When working for a city I often have several programs open at a time. Broadband would help significantly.

- access the library's free WiFi day and night because they have no other source for Internet connectivity.

Live just outside of town in a development with 5-75 homes (oakview heights and highland trail) and we do not have fiber while communities, towns, and lakes further away are getting more reliable internet. We actually have a FB group for our development where the internet speed has been discussed and no one is happy.
- 23. We educate K-12 students with online content hosted on premise and cloud based in coordination with communication between teachers and students.
- 24. Interestingly, I was just trying to log into my work VPN and the internet connection is so poor, everything stops. So, instead, I have to rework my day until the connection is better. Even at its best, it is painfully slow. I pay for the highest amount of speed available to me.

26. Internet connection is extremely important - my home and business are within the City of Fergus Falls. This is necessary for my professional and personal life. I have no complaints

- 28. Current bandwidth has been sufficient, but with more need for online learning (school district) we are worried about bandwidth capabilities of delivering instruction effectively via an online/virtual means.
- 29. I have fiber to my home/home office and it is amazing, however it was crazy expensive to get because we live in a rural setting. I have dsl in my office located in the city limits of Pelican Rapids and it is horrible. I repeatedly get kicked off, despite being hard wired into my router. My internet will go down for short periods of time throughout the day. It is very frustrating when trying to upload a file and the amount of time that takes.
- 30. Necessary for all aspects of day to day operation
- 31. Business internet is excellent. My home internet has some speed limitations that would show up more significantly when multiple household users are accessing data at the same time.
- 32. The lack of speed for our business connection has really became pronounced since COVID-19, as we have had to do much more streaming and it is difficult to accomplish with less than ideal internet connections.

Please share your thoughts on how Otter Tail County is positioned to provide the high-quality [knowledge] workforce.

- 1. We are a global workforce and in order to retain and attract a workforce, we need to have all the tools at our disposal, including computer access.
- 2. We need to consider the livability of OTC in regards to things like housing, childcare and healthcare when we're looking at attracting a high quality workforce.
- Otter Tail County with its adverse population in a multiple vacationing lakes area, with many different work situations providing high-quality workforce with proper internet connection would be vital.
- 4. Cost of living is less than elsewhere in the state/ country; access to nature, community leaders are clearly willing to provide infrastructure necessary to bring people to the county.

- 5. With a population of 58,746 people, Ottertail County is ranked 17th in the state in terms of its population. With that in mind, I would say that we are well positioned to provide a high-quality workforce. What we need to consider is if we can provide quality training, depending on what is needed to fill open positions. With access to technology, opportunities to provide people with the essential skills and credentials needed to fill positions is of high importance, as online Post-Secondary training is readily available if they have access to technology.

- 31. From the school's perspective, we have had to switch much of our instructional model to one heavily predicated on the use of technology.
- 32. I would say that COVID-19 has forced businesses to advance technologically. There has been a lot of businesses who have increased social media presence, which is the first thing I notice. However, contactless payments are available virtually everywhere, which is incredibly important as this is the future of payment processing.

How do you see unequal access [digital equity] to technology and the internet creating a divide in Otter Tail County? If you have an example either from your family or someone you know, please share it.

- 1. I think an good example is the COVID 19 and educational delivery to school age students.
- 2. Aside from broadband access being a barrier to people in underserved areas, many people I've been talking to have outdated equipment, so even if they have internet they don't necessarily have the updated technology to host Zoom or use an online camera/mic, etc.
- 3. If access is provided the only thing would be for families to be able to afford it

- 4. Divide between city vs rural access; access is not equitable.
- 5. I think the divide comes with affordability. Those who could most benefit from training for high quality positions, are those with the lowest incomes. Many of the low-income individuals residing in Ottertail County that I have worked with are employed at minimum wage jobs and often cannot afford a high quality Wi-Fi service. Some have computers that need updating or repair to work correctly as well.
- 6. Could be a factor of where someone decides to live based on access.

- 8. Just like in the classroom, if a student has more difficulty seeing or hearing, their grades may not reflect their actual abilities. Lacking good quality Internet access makes it more difficult for students see and hear what is happening in their classroom in either a hybrid or distance learning situation.

- 12. In rural areas or in some areas of our City, it may not even be available. This becomes difficult for students and people that need to work from home.

- 14. I work in the public library field. While more people have access to devices (smart phones), affordability of regular internet service and/or lack of access to broadband internet service continues to be a concern. In addition, a widening skills gap is apparent. As more and more moves online--access to employment, healthcare, government services, financial services--some are being left behind. And these are the basics--as more and more jobs become high-tech, low-cost low-barrier opportunities to re-skill and access to tools, resources and services to assist is needed.
- 15. Outside of Fergus Falls and Perham the ability for high speeds are not available
- 16. AARP set up a tax preparation center for low income or for those who do not have access to internet; however when the CCP virus shut it down, I am unsure how those individuals had their taxes done as paper filing is difficult to do without online access to the forms.
- 17. We are already an OUTSTATE community, but we have fiber optic to the curb intown... those that are out of city limits are mostly limited in access. Creating an additional burden and divide
- 18. Some have great access (me) while others do not, creating equity issues. Also, the cost can be prohibitive for some.
- 19. There are areas, sparsely populated that can't get access to high speed internet because the providers can't profit off them because their cost is too high getting to them
- 20. Fiber to the home is best, but access through wireless networks can work. ie: VZ system.
- 21. Each and every day I encounter people who do not have Internet connectivity or adequate Internet access because it is either not physically available or cost-prohibitive. I am aware of grandparents trying to use their cell phones for wireless access to help grandchildren with at home learning. Wireless connection is a bandaid and not a solution. If an adult has permission to work from home but lacks Internet access to so, they are at a terrible disadvantage. So too are children trying to learn from home.

- 22. Obviously, it will become more of an issue with distance learning, work from home, netflix, hulu, zoom meetings, etc. More with slower internet will possible learn less, have issues working which will make them work more, and will cause issues with perceptions.
- 23. It is very population density driven. There are remote areas with no access to broadband and smaller communities with little or no competition for Internet access pay much more for less.
- 24. When I can't do my work, of course it is going to affect how successful I am or can be. Mine might be on a smaller level, but for others, this can be huge.

26. To be honest, with 99.5% of my work within the city, I'm not as knowledgeable regarding unequal access, however, I am aware it exists, with residents, businesses and students (distance learning).

- 28. Definitely believe this exists for some of our families that we serve in terms of quality highspeed access in some of the rural areas of our school district.
- 29. I see disparity primarily in pretty much every corner of life, however, I see the most disparity in the school systems. In Pelican Rapids, for some homeowners/renters, even where fiber is available, it is too expensive (either perceived or real) to have. With students now required, at least partially, to distance learn by use of technology, the students with poor access are going to fail at higher rates. This is assuming that the computer equipment they have is adequate. Some equipment is provided by the school, however, most of that is below adequate, outdated, or poorly maintained due to lack of staffing or lack of knowledgeable staffing. Training is almost non-existent for students and teachers/staff alike. If we continue along this line, we will be failing our students.
- 30. Distance learning and agricultural applications necessity and access to it through broadband is essential
- 31. It is essential from an equity standpoint that all children have access to high speed internet when we are using a distance learning model for education.
- 32. I know that depending on the areas there are different speeds available, this makes it difficult to live outside of a town in OTC. Rural members, such as my parents, are subject to painstakingly slow internet due to where they live. If this would be remedied it would most likely increase rural populations as those who work from home would be able to be out of town.

What assets should we emphasize in our [advocacy] efforts to attract people and investment to the area? What else should we be doing to strengthen Otter Tail County to make it more attractive for development and to improve the quality of life?

- 1. Safety, both health and personal safety.
- 2. We really have the full range of offerings here arts, recreation, healthcare. We need to continue to check in with those industries to make sure we're doing what we can to protect and enhance them. We also need more options in quality childcare and housing, and more friendly tools about how to start a business here.

- 4. Proximity to nature and the ease with which people can enact change or be involved civically is what drew me back to the area.
- 5. I think the quality of life is fantastic in Ottertail County. There are affordable housing options, decent job opportunities, safety, lower cost of living than in a city or suburb, access to many outdoor activities, access to major interstates, and a sense of community.
